# REHABILITATION AND UPGRADING OF SEMI-CENTRALISED SEWERAGE SYSTEMS IN KIGALI ESTATES

### 1. PROJECT BACKGROUND


With the aim to attain the Rwandan Government targets related to 100 per cent scale up of access to sanitation services by 2024 as per the fifth priority area of National Transformation Strategy, entitled "Moving towards a modern household" on its key strategic interventions named "Access to sanitation and hygiene will be scaled up to all from 84% (Est.2016) to 100% and waste management systems will be developed in cities, towns and rural areas" the Rwanda Sustainable Water Supply Program was set up in order to implement various projects regarding to water supply and sanitation towards overall improvement of the public health situation in the target cities and their surrounding areas, as a result of more reliable improved water supply and sanitation services.

From the above perspective, the Government of Rwanda has acquired financial loan for implementation of the Program under which "the rehabilitation, upgrading of semi-centralized sewerage systems in Kigali Estates" which were assessed to have issues of non-functionality.

# Scope of the project


- Project name: Rehabilitation, Upgrading of Semi-Centralized Sewerage Systems in Kigali Estates

  - Scope of work under rehabilitation: Rehabilitation and upgrading of semi-centralized sewerage systems in 8 Estates (Kacyiru, Vision 2020, Vision City, Umucyo, Lagoon Nyarutarama, Urumuri Village, Sunset, Kagugu Villa, Kabuga Hillside, Masaka Hill view, Gate hills 1, Gatehills 2, R&B Martins, Nyiramana and Mountain Ridge);
- > **Source of funds:** African development bank (AfDB)
- > Implementer: WASAC Ltd
- > Stake holders: MININFRA, MINECOFIN, MoE, CoK, REMA, Gasabo District, Kicukiro District
- **Beneficiary**: Estates owners and inhabitants

Through the Implementing Agency, WASAC Ltd, the studies for the above mentioned project was conducted in fifteen (15) Estates among which 8 were concluded to be rehabilitated.




