

The Government of Rwanda has received financing from the African Development Bank (ADB) hereinafter called the Bank toward the cost of the Rwanda Sustainable Water Supply and Sanitation Program, and intends to apply part of the proceeds toward payments under the contract for purchase water meters. For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the Bank's Disbursement Guidelines and procedures for Investment Project Financing, except for those payments, which the contract provides to be made through letter of credit.
- 2. The WASAC DEVELOPMENT Ltd now invites sealed Bids from eligible Bidders for purchase water meters.
- 3. Bidding will be conducted through the Open Competitive Bidding (International), (OCBI) method as specified in the Bank's Procurement Framework Procurement Policy for Bank Group Funded Operations dated October 2015, and is open to all eligible bidders as defined in the Procurement Framework.
